PGT (POLITICAL SCIENCE), MALE POST CODE-114/17
IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 dated 22/12/2017 had advertised total **88 vacancies** {**UR-47, OBC-22, SC-13, ST-06 (including PH/OH-01 & PH/VH-01)**} for the post of **PGT (Political Science), Male under Post code-114/17** in Directorate of Education with closing date as 31.01.2018. Tier-I examination in offline written examination mode was conducted on **05.08.2018**.

2. On the basis of online examination of Tier-1 held on **05.08.2018** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of PGT(Political Science), Post Code-114/17 in Directorate of Education, a total of **81 candidates (UR-45, OBC-18, SC-13, ST-05, including PH/OH-01, PH/VH-01) and 06 candidates (UR-02, OBC-03 and ST-01)** were provisionally nominated vide **Result No.417 dated 30.04.2019** and **Sup Result No.485 dated 30.07.19** respectively. The candidature of one candidate under OBC category having roll No.2370009545 was kept pending to whom second opportunity was given to upload deficient document between 30.07.2019 to 05.08.2019. However, he could not be recalled in stipulated time due to some technical problem. Therefore, now a fresh opportunity is being given to him to upload deficient documents.

3. Further, the dossier of **Six candidates (UR-04, SC-01 and ST-01)** has been returned by user department vide letter dated 25.02.2020 after cancellation of their candidature with the request to provide substitute from waiting panel. A waiting panel has already been prepared for all categories which will be valid for a period of one year from the date of declaration of result. As the main result to this post code was declared on 30/04/2019, the waiting panel is valid upto 29/04/2020. Accordingly, these 06 dossiers were received before expiry of waiting panel. As per waiting list of UR category the candidate at W-4 has already been nominated in OBC category as per his merit. However, now due to return of dossiers by user department the merit under UR category has been lowered and the said candidate need to shifted to UR category thereby creating a vacancy under OBC category. Consequently, one candidate need to be nominated under OBC category. Therefore, only Seven candidates (**UR-04, OBC-01, SC-01 and ST-01**) available immediately below the last nominated candidate under respective category in waiting panel is being provisionally nominated.

4. Accordingly, in continuation to **Result Notice No.417 dated 30.04.2019** and **Supplementary Result Notice no. 485 dated 30.07.19** the candidates detailed below are also provisionally selected on the basis of offline examination of Tier-I held on 05.08.2018 and having been found provisionally eligible as per

documents uploaded in support of educational qualification etc. in accordance with advertisement No.04/2017 and RRs for the post of **PGT(Political Science) Male, Post Code-114/17.**

5. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. **The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to**

the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, **DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2008, O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.**
9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential

Certificates as per instructions issued by Govt. of India in this regard vide **MHA O.M. No. 2/29/54-RPS, 19-11-54.**

10. The user department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.

11. The recruitment process for the post Code-114/17 stands closed in all respect subject to outcome of pending court cases (if any) and except 01 pending candidate, as per details given below:-

12. The e-dossier link for above purpose shall be activated from 29.09.2020 to 03.10.2020.

13. The abovesaid candidate is being given last and final opportunity to upload pending/ requisite/applicable documents in the e dossier module within the stipulated time, i.e. from 29.09.2020 to 03.10.2020 failing which his candidature will be rejected and no further opportunity will be given whatsoever.

13. Further, as per Result Notice No.417 dated 30.04.2019 wait list/panel for the post code 114/17 has already lapsed on 29.04.2020.

**** Kindly note at sub para -vii of para-2 (Mode of Selection) in the Advertisement No. 04/17, that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference" in case of further tie, candidate having higher marks in Section "A" of the test shall be preferred.**

15. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
