SUPPLEMENTARY RESULT NOTICE NO: 674 DATED 25.09.2020

TGT (SOCIAL SCIENCE) MALE, POST CODE-137/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total 303 [UR-163, OBC-62, SC-32, ST-46, including PH (OH-05, VH-04)] vacancies for the post of TGT (Social Science) Male, Post Code-137/17 in Directorate of Education with closing date as 31.01.2018. Tier-I examination in offline examination mode was conducted on 09/09/2018.

2. On the basis of offline examination of Tier-1 held on 09.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT (Social Science) Male, Post Code-137/17 in Directorate of Education, a total of 282 (UR-157, OBC-50, SC-31, ST-44 including 06 PH) candidates were provisionally nominated for the post of TGT (Social Science) Male, Post Code-137/17 vide Result Notice No. 452 dated 28.05.2019 and the candidature of 12 candidates (UR-06, OBC-03, SC-01, ST-02 including 03 PH) was kept pending for want of deficient documents / clarification and their documents were recalled w.e.f. 31.05.2019 to 09.06.2019 and 02 candidates were kept pending for court case. Further, 14 candidates (UR-04, OBC-07, SC-02, ST-01 inc. 02 PH) were provisionally nominated vide Supplementary Result Notice No. 515 dated 25/09/2019 and 09 vacancies were kept pending for want of deficient documents and court case.

3. Now, the User Department vide letter dated 26/12/2019, 15.01.2020, 06.03.2020, 17.03.2020 & 28.07.2020 has returned the dossiers of 63 candidates (UR-26, OBC-21, SC-11, ST-05 including 02 PH/OH) after cancellation of their candidature for not appeared for documents verification in the User Department. The dossier returned vide letter dated 28.07.2020 is after expiry of waiting panel and hence, not to be taken into consideration. Accordingly, 62 candidates (UR-26, SC-21, SC-11, ST-05) have been taken into consideration from the waiting panel as per their merit.

4. (i) Accordingly, in continuation to Result Notice No. 452 dated 28.05.2019 & 515 dated 25.09.2020, the candidates, as detailed below, are also provisionally selected on the basis of offline examination of Tier-1 held on 09.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT (Social Science) Male, Post Code-137/17 in Directorate of Education.

5. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. **The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment**

letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.


8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

11. The candidature of the following candidates are being kept pending for want of deficient / requisite documents in the e-dossier. These candidates are required to upload deficient documents in the e-dossier, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground:-

The candidates bearing roll no. 2680020661, 2680020342, 2680004683, 2680003025, 2680007205 & 2680000407 are being given 2nd and final opportunity to upload the deficient /requisite documents in the e-dossier w.e.f. 29/09/2020 to 03/10/2020, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground. The e-dossier module link for the above purpose shall be activated from w.e.f. 29/09/2020 to 03/10/2020.

13. Further, the candidates bearing roll No. 2680000988, 2680010493 are being given 1st opportunity to upload the deficient documents in the e-dossier w.e.f. 04/10/2020 to 13/10/2020. The e-dossier module link for the above purpose shall be activated from w.e.f. 04/10/2020 to 13/10/2020.

14. The result process for the above post code stands closed in all respect except 10 vacancies (08 vacancies as referred at para-11 & 02 vacancies for court case candidates).

15. A waiting panel which was valid for a period of one year from the date of declaration of result i.e. upto 27.05.2020 has been expired.

16. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

17. The category wise marks obtained by the last selected candidates have been given as under:-

Note:- In advertisement no. 04/17, in para-2 (vii) - Mode of Selection (Examination Scheme), it has been mentioned that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference. In case of further tie, candidate having higher marks in Section "A" of the test shall be preferred".
