1. The DSSSB vide Result Notice No. 971 dated 12/03/2020 has provisionally selected 340 candidates for the Post of Warder under post code 86/17 in Delhi Prison Department. The Board had conducted Physical Endurance Test (PET) for the applicants of the post code from 01/03/2019 to 16/04/2019 (36 days) at Chhatrasal Stadium, Model Town, Ring Road, Delhi-110009 and Sports Complex, East Vinod Nagar (Mayur Vihar Phase-II), Near Neelam Mata Mandir, Delhi-110091.
2. In the PET conducted, out of 129072 candidates only 26561 candidates appeared for PET. Further from the 26561 present candidates only 11014 candidates could qualify the PET. The candidates having roll numbers 2890000898, 2890020481, 2890036647, 2890055870, 2890074605, 2890077759, 2890079636, 2890082629, 2890086841, 2890087399, 2890090746, 2890109157 and 2890110413 belongs to OBC (Outsiders) thus were considered in UR Category. These 13 candidates were overage in UR category therefore not eligible for shortlisting for written examination in UR Category.
3. On qualifying PET, vide notice no. 781 dated 10/05/2019 and corrigendum no. 782 dated 17/05/2019, 11001 candidates were provisionally allowed to appear for written examination for post code 86/17, subject to correctness of the information furnished by the candidates in their online application forms. Out of these 11001 candidates, 9387 candidates appeared in written examination held on 18/06/2019.
4. Further, the candidature of 49 candidates (UR-20, OBC-12, SC-12 and ST-05) were kept pending vide Result Notice No. 971 dated 12/02/2020 for want of requisite documents/certificates. Now on preliminary scrutiny of the additional/requisite documents furnished by these candidates, whom candidature was kept pending for required documents, in accordance with the advertisement no. 03/2017 and RRs for the Post of Warder under Post Code 86/17 in Delhi Prison Department, the following Candidates are hereby provisionally nominated as per their merit:-

5. The candidature of 01 OBC Candidate having roll no. 12360401364 which was earlier kept pending vide Result Notice No. 971 dated 12/03/2020 is now rejected in OBC Category as the candidates is not eligible to seek the reservation benefits under OBC Category in Delhi being OBC Outsider.
6. Further, out of 49 candidates whose candidatures were kept pending for deficient documents, the candidature of the following 09 (Nine) candidates are still kept pending for the reason mentioned against their roll number as below:-

Now therefore the above pending 09 candidates (UR-06, OBC-02, and SC-01) are being given **second and final opportunity** to upload their pending/all requisite/applicable documents through the e-dossier link on OARS module of the Board within stipulated time. **The e-dossier link shall be active from 17/06/2020 to 21/06/2020** failing which their candidature will be rejected and no further opportunity will be given on whatsoever grounds. The above candidates are also being separately informed through, SMS on their registered mobile number.
8. The selection of the above 40 candidates (UR-14, OBC-10, SC-11 and ST-05) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. **Further, the User Department shall arrange measurement of physical standards, i.e., Height and Chest and also checking of defect or deformity (including bow-legged, Knocked Knees, Flat feet, etc.) of the candidates as per the requirements of the RRs, which has not been done by the DSSSB, before issue of appointment order.**
9. The Selection of the above 40 candidates (UR-14, OBC-10, SC-11 and ST-05) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting

applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

10. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Delhi Prison Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
11. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
12. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 and 13/05/2017.
13. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.

14. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
15. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
16. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
17. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
18. The category wise marks scored by the last candidate provisionally nominated are as under:-
