

## NOTICE

The India Government Mint, Hyderabad had conducted an Online Written Examination (Phase-I) for 10 posts of Junior Office Assistant at B-3 Level on 07.11.2020. Result of the Phase-I selection process has been declared on 18.11.2020 declaring 776 candidates provisionally qualified for appearing in the typing test on computer (Phase-II) based on the performance of the individual candidates and their obtaining the minimum qualifying marks prescribed by this Mint .

- Phase-II of the Selection process containing a typing test on Computer has been held on 22.12.2020 and 23.12.2020. A total of 684 candidates have actually appeared in the typing test on computer (Phase-II) held in the above dates.
