2.0	Eligibility Criteria																																		
2.1	Age Limit	Up to 65 years of age																																	
2.2	Validity of the scheme	Up to 01.12.2019																																	
2.3	<p><u>A. FOR SUPERVISORS</u></p> <p>The eligibility criteria for re-engagement of Supervisors in the above categories is as follows :-</p> <p>1. Maintenance Unit (Mech.) :- The retired Mechanical Supervisors who have worked in Mech. dept. of RWF are eligible to apply. However, for the posts to be utilized in EMMS & RT Shop retired Supervisors from Mechanical Department of Indian Railways with experience in Maintenance are eligible to apply. It may please be noted that preference will be given to those retired from RWF.</p> <p>2. Control Group :- The retired Supervisors from Electrical Department who have worked either in Axle or Wheel Shop of RWF are eligible to apply.</p> <p><u>B. FOR TECHNICIANS</u></p> <p>The eligibility criteria for re-engagement of Technicians in the above categories is as follows :-</p> <p>1. Technician – Fitter Maintenance: - The retired Technicians who have worked</p>																																		

	<p>either in Axle or Wheel Shop of RWF are eligible to apply.</p> <p>2. Technician – Machinist :- Retired Railway Employees who worked as Machinist in any organization of Indian Railways are eligible to apply. Preference will be given to those retired from RWF.</p> <p>3. Technician - Control :- The retired Technicians from Electrical Department who have worked either in Axle or Wheel Shop of RWF are eligible to apply.</p> <p>4. Technician – MMV :- Staff retired as MMV from any organisation of Indian Railways and possessing a valid driving licence for driving Heavy Vehicles (HVM licence) are eligible to apply. Preference will be given to those retired from RWF.</p>
3.0	The re-engagement shall be upto 01.12.2019 or upto the age of 65 years or till filling up of the posts through other modes, which ever is earlier.
3.1	The Administration reserves the right to terminate the services of the re-engaged retired Railway Employees at any time, in case their work or conduct is found to be unsatisfactory or even in administrative exigencies. The decision of RWF Administration in this regard shall be final.
3.2	The employees who were Removed/Dismissed/Compulsory Retired as a result of disciplinary action or other wise are not eligible for re-engagement.
3.3	Monthly remuneration of a retired employee being re-engaged will be determined by reducing pension from his/her last pay drawn. (i.e., Basic Pay + D.A)
3.4	The re-engaged retired employees are not entitled for any other benefit or any other facilities except monthly fixed remuneration.
3.5	The re-engaged retired Railway employees will be eligible for 8 days of leave in a calendar year. For absence, if any, beyond this period appropriate deduction will be made from the monthly remuneration.
3.6	The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
3.7	Re-engagement of retired employees shall be subject to prescribed medical fitness for the category in which they are re-engaged.
3.8	Suitability/Competency of the applicant will be adjudged by a committee of Officers before their re-engagement and only those candidates found suitable will be considered for re-engagement.
3.9	The duty hours of the re-engaged retired employees, would be as prescribed by this administration from time to time.
3.10	The Re-engaged retired employees shall be discharged immediately on joining of selected candidate from RRBs.
4.0	How to apply
4.1	Applications should be submitted strictly in the prescribed format as per Annexure. It shall be filled in A-4 size paper.
4.2	The application format is also available for download in the RWF website www.rwf.indianrailways.gov.in
4.3	One passport size photograph should be pasted on the application form at the space specified.
4.4	Self-attested photocopies of the following documents should be enclosed:-
	(i) Service Certificate
	(ii) Pensioner Identity Card
	(iii) Pension Payment Order (PPO)
4.5	The applicants should bring all the original certificates when they are called to appear for assessment of suitability/competency.

6.0	GENERAL INSTRUCTIONS TO RETIRED RAILWAY EMPLOYEES.
6.1	The final decision in the matters relating to eligibility, acceptance or rejection of the application, mode of selection, etc rests with this administration.
6.2	RWF Administration reserves the right to alter the stages of re-engagement process or cancel part or whole or the entire process at any stage without assigning any reason.
6.3	Incomplete applications, applications which are not in the prescribed proforma and applications without requisite enclosures will be rejected and no correspondence will be entertained.
6.4	The interview is tentatively fixed on 23.10.2019 at 11.00 Hrs. in the administrative block. Since the interview is to be conducted at short notice, the intimation regarding the interview will be sent by e-mail and also by post. The list of applicants, eligible to be called for interview will be published in the notice board and also in the website of RWF. All applicants are required to watch for the eligibility list for interview published as above.
